

Chapter 8

Today in Israel, it is clear as an Israeli or as a Jew, if you oppose what is happening you will be treated as mad, or a Palestinian or both. Ironically if you are true to Judaism, you will find yourself Orthodox and irrelevant. If you are a Palestinian Christian, you will still be a Arab, first and foremost. We mentioned earlier the British – Israel related website which likened Billy Graham as an Old Testament prophet preaching to President Bush to release the wrath of Gods tomahawks.

Yet the irony is that Moses, Nehemiah, Haggai, Elijah or Ezekiel would be preaching against the Knesset and against modern Israel. Can Dagon or Molech or Baal be likened to a Marxist central government which Israel has predominantly been since 1947.! ? Marx himself would have enjoyed the analogy, if not the sentiment.

Would King David have decreed “religion is the opiate of the people” its doubtful, The dome of the rock is an obvious symbol to demonise and is obviously Muslim, to Orthodox Jews a sure sign of the “Moon God”, but when it looks at its own society what does it see?

Rabbi's are aware of Jehovah's ability to dismiss the enemies of Jerusalem but, they realise even more that the transgressions by the chosen people are dealt with more severely and just as swiftly, and no matter how many weapons a country has, or how many superpowers it controls, spiritual reprimands are Omnipotent and irresistible.

Like the famous novel and film, which is historically accurate “The House on Carroll street”, the Nazis who fled Germany did so by disguising themselves as Jews, by taking the identities of dead Jewish children, and entering into any country but especially America and Britain sometimes with the assistance of the military elite. Thus the horrible irony is the lunatics have taken over the Asylum, and are posing as the chosen people.

Just as Jewish people are victimised down through the centuries, and (ironically many Jewish people are responsible for running co-operatives and finance houses which offer % interest on loans, as this helps the poor) Jewish people can victimise the Palestinians today. The bible however, promises salvation to the Jews and Isaac⁵⁶⁷ and also to the Arabs and Ishmael,⁵⁶⁸ (although President Bush or Billy or Franklyn Graham will not be mentioning it in their prayers for the day), and of course to the Gentiles through Christ. How then can this type of sectarianism and closely personal hatred be sustained and how did Israel come to be in this position today?

Israel was chosen as the Father of the twelve tribes. Descended from the Hebrew slaves, enslaved in Egypt, they were a nation without food in a world of many nations. The history of the bible marks their father as Noah, who was also the father of all the nations on earth. Initially it seems these nations were dispersed at Babel and their languages confused, whereby they filled the earth. The outer known areas of which were known as the Isles of the Gentiles⁵⁶⁹. By the time Moses led them out of Egypt and where they were joined by non “Hebrai” (the wanderers) or strangers, many nations outside to the east and west, north and south of Israel were occupied by different tribes, who were migrating or remaining in the areas we commonly know today as Europe, Asia, Russia, Africa and possibly America, north and south and perhaps Australia.

The tribes of Israel were originally the seed of one man and woman and they inherited the Promised Land, nearly the same land we know today as Israel.

Their greatest King (King David) united both parts of Israel, Judah in the south and the ten tribes in the north into the United Kingdom. This kingdom was eventually captured by the Assyrians in 722BC, some 1300 years after the dispossession from Babel. Therefore in these 1300 years it is (for example the Assyrians) extremely likely that Europe and Britain and Scandinavia was already teeming with people.

During the division of the United Kingdom and the opposition of Jeroboam before the Assyrian led Babylonian captivity, the Levites, a tribe of priests without land or domain and the faithful of the northern ten tribes, removed themselves to Judah (in the south)⁵⁷⁰ at which time God spoke to all Israel in Judah and Benjamin, later more came over.⁵⁷¹

Sargon (the Assyrian) captured 27,290 Israelites, who were taken to Assyria and Babylon, they did not roam over Europe and indeed Nehemiah returned to those remaining in Judah (see chapter 4). Isaih calls all the later captives in the Babylonian captivity, the “House of Jacob” “Israel” and “Judah.”⁵⁷²

After this Jews and Israelites were interchangeable, although Judea was the place of residence not Israel as mapped today. The gospels speak of Anna from the tribe of Asher, Christ spoke to the Samaritans, but appealed to the “lost sheep of Israel”⁵⁷³ Paul was from the tribe of Benjamin and spoke to the house of Israel⁵⁷⁴ etc., therefore the British Israelite claim that the lost tribes were the Fathers of European Nations and therefore the west is tenuous at best considering the core of Israelites were still in Judah. This is

not to say however, that Israelites and Judah did not migrate, but the whole essence of the Promised Land was to return and stay within it. the brutality of the Assyrians was horrifying, and how many of the Israelites could have survived, is hard to imagine. The Passover being a yearly draw on Jewish peoples to return etc.

What appears in scripture around the captivity of Babylon between 723BC and 600BC is the Pharisees and the Babylonian Talmud, which is in essence, the law given by Moses, but has within it additions from the Oral tradition during the captivity. Babylon was the centre of Chaldean science of metaphysics and the history of the first few books of Genesis becomes elaborated upon with alternative versions of the temptation of Adam and Eve and so forth. This Talmud or law orally added, formed the Sepher ha Zohar and the foundation for mysticism we now know as the Cabala. Therefore the additional law, the Pharisees and the Cabala (in much looser form in writings at least) all appear at the same time. They were in effect the intelligentsia, who subversively wished to take power from the Sadducees high Priesthood to form an alternative intellectual aristocracy, as opposed to blood and birth.

During the time of Jesus Christ it was they, above all who regarded the Rabbi (Yeshua..Hebrew/Aramaic. Jesus...Greek) as a heretic and when the Temple was destroyed by the Roman General Titus, they became the dominant power within Judaism as the Sadducees fell with the Temple, and a lot of the blood lines and genealogies fell with them in this dispersion. The Sadducees did not believe in an afterlife or Angels.

This was not the case with the Pharisees with their mystical teachings laying the groundwork for the Cabala, which is heavily reliant on "fallen" Angel worship, inspired the imaginations of the Jewish populace.

Belief in angels and fallen angels was instrumental to the Cabala and this fact was also a downfall of the Sadducees. This internal battle for power continued up with the dispersion of the Jews by Hadrian in 132AD and it was from this point on the Talmud and Sephor ha Zohor was made into written form.

The Sadducees rejected this new law and under the Pharisees others who rejected it were the Samaritans (they were seen however as a mixed race since the Babylonian captivity) who stuck rigidly to the first true books of the law (the Pentateuch the first five books of the Bible).

Political power with a cursory observance of the religion of Israel to appease the people became the impetus for Judaism mixed with esoteric Cabala and mysticism. The emphasis therefore in Judaism changed from the Mosaic

expectation for a Messiah, a spiritual victor but a temporal king, who would restore Israel and control the nations surrounding. Many Jews however, had dispersed and or had formed communities to a new Jewish sect called Nazarenes, who eventually became Christians and it was this sect which eventually in name at least, conquered the Roman Empire, which took it as the official religion of the Roman Empire.

The Sadducees had already reduced the law to be subservient to Hellenism,(Greek culture) insisting on strict conservative values, whilst the Pharisees stressed the grace and forgiveness of God, but under the politicised Babylonian philosophy. Yet throughout their history they had retained their original monotheistic belief and had clung to the law

Without a temple (destroyed by the Romans in 70 AD) they would become fragmented and disperse which is the true beginnings of the Jewish Diaspora, even adding proselytes to their numbers. Judaism already added to in Babylon then merged with Greek culture and or (again) Persian Zoroastrianism, and the book of Zondavesta, the struggle between the “Dark” God and the “Good” God. A belief which heavily influenced Freemasonry and contemporary’s like Frederick Nietzsche. Competing with these beliefs were as mentioned the Greek philosophers Socratic, Platonism, Aristotelian, Neoplatonic, Epicurean, Stoicism, Cynicism and even the mystery religions of Isis and Mithras. Despite this and a hostile Roman Empire and a dormant Christianity Judaism has survived to this day.

No matter how transformed the law becomes, the Mosaic Law provides a follower to be different to remain separate. From birth a Jewish boy or girl are taught the tenants and are different by the time they reach maturity. The point about the law is that it is adaptable to expansion, but does not allow the outside to invade it, even if added to or falsely interpreted. As the Jews dispersed into every country in the world they naturally remained unchanged, whilst able to assimilate themselves into the country they arrived in. This naturally antagonised the inhabitants seeing the Jews as wanting it both ways, having their cake and eating it, whilst they were simply following the tenants of their law, faith and history. It is this last issue which becomes central to the Judeo-Christian tradition.

Their homeland in Jerusalem saw the building of a new temple and pilgrimages of Christians to see where the Messiah had died and resurrected. Even when the new Arabians and the followers of Mohammed captured Jerusalem in 637AD, these pilgrimages were allowed to continue under the protection of Caliph Omar who directed the protectorate Sophronius the

Patriarch to protect and secure their lives, fortunes and churches⁵⁷⁵. This changed under the Turcomans who captured Jerusalem in 1064. To oppose this, the wandering group of Normans, who had captured France and Italy and Sicily amongst other areas, led crusades to recapture Jerusalem and clear Palestine of the Turcomans, ... but not against all Muslims. Eight crusades later and the Knights Templar began a banking system which would remain up to this day. The effort of moving large amounts of men, knights and civilians in their thousand across Europe to Jerusalem, meant outposts were set up.

People deposited their gold bullion and jewels and spices with the Templars who simply gave, pieces of paper to take to the next post or Priory.

Soon the idea of lending paper as money, reappeared in Europe marking the beginnings of a new banking system. the older idea of lending 10 notes of promises to pay when only 9 were in existence also reappears inevitably.

Jerusalem finally fell in the 1400s, and remained a Arab country even though “Arabians” had long lived in palastine or the promised land. A pertinent point when capturing the promised land was not the killing of “others” but the establishment of a people who worshipped the one true God one and all. After the fall of Jerusalem in the 1400s , not until 1947 we are led to believe Israel once again became a nation in one day.

As discussed in earlier chapters the Knights Templars, fragmented into many differing orders including the subsequent Knights Hospitaliers, the Knights of Malta, which also in its degrees, has similarities with the Black institution of the Orange Order, and the Priory of Sion.

Various grandmasters of these groups depending who held power, and was more prolific financially, bestowed themselves with titles of Kings of Jerusalem. Indeed Queen Victoria had this in one of her titles as does Prince Michael of Albany HRH Prince Michael James Alexander Stewart (see chapter 4 & chapter 5) (belonging at least to the Chivalric Order of the Knights of Jerusalem). Even Napoleon once he became Emperor, married his brothers and sisters and cousins into the Royal houses of Europe, extending into nearly every branch. The European blue bloods today have Napoleons blood running through their veins ... these titles have been a curiosity to most historians preferring to see them as the spoils of conquest, rather than having any birth or bloodline value.(at least in public at any rate). The history of Europe has been littered with Kings and Queens who see their bloodline as blue rather than red and as divine, and today the facile world of politics as related through the media rarely discusses these issues as also being a central cause of wars, treaties and or motivations for daily world events.

In the intervening years (after the capture of Jerusalem in 1064) the Jews were expelled from England and Spain and generally suffered under the Christian dominated world, where they were employed in trades which Christians found distasteful .. especially that of moneychangers which by its nature of exchange Christians and Islam were in any case complicit.

Their international nature made them especially useful in diplomatic circles and also in espionage. They were for instance, accused as being the cause of punishment to Spaniards who admitted them into Spain and gave them shelter. The punishment (from God) was the Black Death⁵⁷⁶. This was declared by the Spanish inquisition. This and the destruction of the temple by the Romans naturally endeared the Jews to the Protestant faith, (as long as the protestants were not National socialists or Nazis or Anti –Semites like Martin Luther !) although King Edward of England cited the expulsion of the Jews from England as beneficial to the country.

Even the Magna Carta has provisions to prevent the Jews entering into usury or usurping the role of Christianity, provisions which continued after the reformation.

Reaching a ceiling in many professions, those very provisions, preventing Usury channelled them into roles of moneychangers, a superior knowledge of diplomacy and trade routes and how to profit in whichever market they choose

Following the Dutch revolution, the glorious English revolution and the French revolution, the merchant classes were able to operate in a freedom which had not existed before. The Jews also found freedom under these conditions and following the Napoleonic Wars in 1800 – 1815, an organisation called the L'Alliance Israelite Universelle was founded in 1860. It was a political organisation, which pertained to rule all Jewish peoples in whichever country they lived and despite the government of that country, members included Moses Hess and Asher Ginsberg It was represented “neither by state nor by a society, nor does it occupy a clearly defined territory”, therefore its aims were to give cohesion to an international Jewish nation and not to re-occupy Palestine.

The Universelle was preceded in 1843 by a purely Jewish form of Freemasonry admitting only Jewish members, the “Independent Order of B’Nal B’rith”.

The L'Alliance Israelite Universelles first public meeting and political declaration was at the Berlin congress in 1878

A member of both was Adolphe Cremieux. Later Asher Ginsberg left the L'Alliance and became the Prophet of Zionism which emerged, most

prominently in 1897. By this time the acceptance of a new Jewish role in freemasonry and in world politics was facilitated by the joining of the “Order of B’nai B’rith” with the 18th degree of the Ancient and Accepted Scottish Rite Freemasonry which extended to 33° in total. Thus both orders were interlocking and members were accepted at this point. This meant that more Jewish freemasons could rise into positions of power.. A fact which Hitler later was to attempt to remedy 70 years later.

Whichever form the new Israel would take, it was necessary for Jewish people to increase in numbers in Palestine. In 1882, Baron Edmund Rothschild was approached by the Grand Rabbi of France in order to procure funds for Jewish colonists to Palestine⁵⁷⁷. His first finances went to send 101, Russian Jews into Palestine. Ploughing land, draining swamps, digging wells and building houses, Baron Rothschild ensured the Turks who were in charge of Palestine at the time allowed the colonies to prosper. He also intervened if any of the new colonists went bankrupt. This began the influx of Jewish settlers in their hundreds and later their thousands.⁵⁷⁸

A problem arose however in 1889, during a sabbatical year. The laws in Leviticus and Deuteronomy concerning Sabbatical years meant that the land could not be worked or tilled every seventh year .. to let it recover and because God decreed it so. This matter of the law blunted the impetus and threw the plans of the Zionists and the Baron into disarray.

Despite their remonstrations, the Rabbis in Jerusalem would not allow work to continue.⁵⁷⁹ A series of conversations with world Rabbi leaders still led to no solution, however, not to be undone, a solution was devised. All the Jewish land in Palestine would be sold to people of another faith. The settlers would then be working for non-Jews .. which was permissible and not for themselves. The Rabbis of Jerusalem cried blasphemy and threatened to excommunicate anyone caught working. However, Edmund Rothschild had persuaded Rabbi Isaac Elchanan of Lithuania to decree settlers could work in the Sabbatical year, for the benefit of the soil of Zion.⁵⁸⁰ Orthodoxy therefore was thrown out for political expediency at the outset of the new Israel and is in essence Apostasy .. yet to nationalists does this matter, well no it does not and criticisms of the Rothschild’s fail to take this into account .. being nationalist and critics themselves. Christianity could hardly object since potentially non-Jews could inherit Israel by becoming Christians in Christian theology. This is the source of some very long conversations.

It is a question rarely put but there are substantial amounts of Palestinians who are Christian.

Jewish historians have divided the world into Jews and Anti-Semites, but it is also a Jewish view that Jewish historical survival is down to their role in commerce, and usury thus they are a class (separate) and people with their own ethnic identity and shared religious and linguistic features⁵⁸¹, this view was shared by Marx (who was Jewish) and almost instigated by him.⁵⁸² thus they became go-betweens.

From the 14th century Jews migrated from Western Europe to Eastern Europe to escape the ceiling placed upon them even though some were assimilated into Christian culture and society

Eastern Europe still remained largely feudal up until the 19th century providing room for Jewish people wishing to trade. They were numerous in Russia and Poland as Merchants, Rent collectors, Tax gatherers etc. These Eastern European Jews would become the new colonists to Palestine.

The Jews represented merchant capitalism and when industrial capitalism came forth it threatened the Jewish position.⁵⁸³ Many ceased to be traders, losing their identity as Jews as they ceased to be a separate economic class, many in eastern Europe contrary to some opinions, Jewish people became farmers. However, in the Muslim world Jews also played their part, but here people lived in a “natural” economy i.e. they produced to consume and yet they survived here also ... how can this be explained without returning to the matter that under the covenants given by Yahweh, promises to keep the Jews prosperous i.e. the world's wealth will flow into their hands, seems to resonate.. a criticism of this view is that a direct bloodline to the recipients of the promises of Yahweh is required in order to benefit from its decree.

A theory is then forwarded by Koestler, who says that the Ashkenazim (and Hasidic) Jews were in effect proselytes (converts) to Judaism. They were originally (although this is not clear) Khazars who resided in the Caucasian mountains in the 8th century AD.

It is possible that the Khazars may have been part of the Diaspora which fled Jerusalem in AD70 as they acted as toll collectors from merchants passing through the land, but it seems they only chose Judaism out of the big three, Christianity, Judaism and Islam to avoid becoming embroiled in the Christian – Muslim wars

Accordingly they had no blood relationship with Old Testament Jewry.⁵⁸⁴ Since many of the Ashkenazim (and Hasidic) Jews cannot therefore claim Israel (to which they migrated and were colonised into) as their spiritual

inheritance in Orthodox Judaism, can they fulfil and inherit Gods promise and plan ?

This is vital to Israel's existence. Arthur Koestler is himself Jewish and his research is admitted by the British Israel lobby, although this has not stopped researchers claiming that the Khazars were actually the Babylonian lost ten tribes who settled in the Caucasian mountains and were also the blood relations of the Picts, Anglo-Saxons and Scandinavians. The Picts/Saxons or British/Scots/Irish are either Dan or Ephraim and so the tenuous and complicated debate rolls on.

Eastern Europe Jews whether by conversion from the Khazars or by blood, were incorporated into Russia when Poland was partitioned into Russia under Alexander II (Romonov's...The new Rome) in number they were approximately six million and did not enjoy this new situation under the Romonov's regime.⁵⁸⁵ They responded by planting a bomb assassinating Alexander, although not all the assassins implicated were Jewish. This unleashed a violent backlash of Anti-Semitism. They migrated to escape the unprecedented prosecutions including the extreme fascist "black hundreds" and the "white" Romonov armies after the Russian revolution in 1917. Many Jews took part in the revolution and out of this climate the newly created Israel was to receive its great ideological movements; Jewish nationalism – i.e. Zionism and socialism⁵⁸⁶. These two ideologies have dominated Jewish thinking for the past 100 years.⁵⁸⁷ Two million Jews boarded steamships for the new world and 100,000 ended up in Britain⁵⁸⁸. These two ideologies also became synchronised with Bolshevism,, Bundism, Menshevism and of course Marxism. The predominance (although this is refuted) of Jewish Bolsheviks in Lenin's party defined the term "Jewish bolshevism" as fuel for their enemies⁵⁸⁹, including the British government and the infamous White paper which denounced the Bolsheviks as a "hotbed of Jews" and in which they (the British government) saw the roots and cause of the Irish 1916 uprising and revolution in Dublin.⁵⁹⁰

Zionism at the outset saw the complete removal of Palestinians, man, tribe and village from Palestine and Theodore Herzl notes as much in his diaries.⁵⁹¹ Hiam Breseath a son of Holocaust victims and former Israeli soldier says Zionism literally means expulsion⁵⁹².

The initial Zionist movement was national in its outlook, but it became international when it was absorbed into the Jewish World Agency in 1928. This coincided with the larger growth of the "Orders of B'nai B'rith" which had formed lodges in the United States, Germany, Rimini, Austria and

Hungary. A prominent member and 32° Freemason was Alexander Kerensky a major and prominent force in the Russian revolution. Anyone who doubts the role of Freemasons (but perhaps not freemasonry) in the formation of the Russian revolution and Zionism read “War and Peace” by Tolstoy, it clearly depicts the role in the development spiritual and political of Russia leading up to the 1850’s. Kerensky’s role is also well documented in his own memoirs.⁵⁹³

The influx of Russian Jewish socialists continued even under the new protectorate of Britain. They saw Palestine as a potential colony which would serve British Oil and Petroleum interests (see the Red line agreement and map in the last chapter 7) in the Middle East, just as the colonisation of Ulster served British interests in “Ireland”.

They had already admitted 100,000 Jewish refugees from Russia, yet the decision by Arthur Balfour to declare that they were in support of a Jewish national home and sympathy for Jewish Zionist aspirations⁵⁹⁴ from Balfour an anti-Semite has puzzled researchers for years ... why?

The expulsion of all the Palestinians was further outlined by Vladimir Jabotusky who suggested the Zionists build up a military superiority to break nascent Palestinian nationalism, a proposition called “Iron Wall”⁵⁹⁵. This laid the groundwork for Ariel Sharon’s vision today of slowly squeezing the Palestinians into unliveable shantytowns. Today there are over 600 roadblocks in Israel. Any Palestinian wishing to travel 5 miles to a hospital or to attend university may well take 8 hours to get there .. if they are not shot. The Israelis water supply is 40 times greater per individual than a Palestinian and if they are employed it is in manual low paid jobs.⁵⁹⁶. As the Jewish numbers in Palestine increased, the Palestinians saw the Balfour declaration in 1917 as a mortal blow but still defended vigorously their position, inflicting many casualties on Israelis. They did not take the view that Britain had imposed this new rule upon them but two years later in 1919 Balfour again re-iterated

“For in Palestine we do not propose even to go through the form of consulting the wishes of the present inhabitants of that country”“The four great powers are committed to Zionism and Zionism be it right or wrong, good or bad, is routed in an age-long tradition in present needs, in future hopes, of far profounder import than the desires and prejudices of the 700,000 Arabs who now inhabit the ancient land”⁵⁹⁷,the future hopes being the oil.

Through the fiscal years 1978 to 1982, Israel received 48% of all US military aid and 35% of US economic aid worldwide.⁵⁹⁸ Since Baron

Rothschild worked in the Foreign office at the time of the Balfour declaration, many have concluded this was merely the Rothschild declaration, and indeed the original declaration was written by him.

In 1983, Israel received 2.5 billion out of a total of 8.1 billion worldwide. Special discounts on weapons are given to Israel, tax deductible charitable contributions and commitments to match “all Israeli debts and future debts”⁵⁹⁹. Today comments or statements by Ariel Sharon, who in the early 1980’s was called the King of Israel by his military supporters, became official US policy and repeated weeks later by Presidents and the Whitehouse in general⁶⁰⁰.

Former Israeli Secret Service elite soldier, Victor Ostrovsky, states that Mossad (the Israeli Secret Service) has offices and cells in every city in the world, especially Belgium (Supreme Allied Headquarters N.A.T.O.) and Washington. Of course espionage is a two way information service, but Ostrovsky states that it is Israel who is supreme commander⁶⁰¹, controlling the intelligence services... in telling his story

“It is out of love of Israel as a free and just country that I am laying my life on the line by so doing, facing up to those who took upon themselves to turn the Zionists dream into the present day nightmare⁶⁰².”

Where is Yahweh, has he turned his face away, and set it like flint. The billions and billions of dollars or yen or pounds, Francs, Euros, seen to be providing the support,... not “He who watches over neither slumbering or sleeping”

The Guardian in December 2003 reported Israeli agents and intelligence are training US troops in Iraq to assassinate suspected Al Qaeda members⁶⁰³. What’s the connection.

Indeed many more in the Israeli military, are slowly recognising the situation they have found themselves in. On 24 September 2003, 25 Israeli pilots refused to fly into Palestinian territory, this was a day when a five year old boy was killed.⁶⁰⁴

Jack Bernstein an immigrant to Israel from America a Zionist and former Israeli soldier, sees that Israel is predominantly racist and Marxist and as an American Jew was married to a Sephardic Jewess, whilst he himself was Ashkenazi⁶⁰⁵

Bernstein claims that the term Ashkenazi lent its name to the Nazi party in Germany, which itself killed Jews. these Jews who were killed in the

Holocausts were he claims Sephardic Jews, by the Ashkenazi (eastern European and according to Koestler formerly the Khazars ...non Jews !)
His misfortunes started when he married a Sephardic Jewess and accordingly was classed as a second class citizen of Isreal,⁶⁰⁶ even though she was more likely to be Jewish than they.(so he states)

Although Sephardic Jews are not as low as Palestinians they are treated as second class, making in his heartbroken view Israel a state in which the Goyim (gentiles) rule Israel whilst claiming to be Israeli and/or Jewish.In effect a coup without awareness in the outside world.

Of course both Sephardic and Ashkenazi Jews (A concert of 10,000 Messianic jews was hosted in Jerusalem a few years ago with songs such as “Shouts of Joy”) have converted to Christianity and can always do so, ..however they could no longer be Israeli and would be shunned in any case. Hate and false Gods in the midst of Jerusalem, and this is not Islam. Its sure protection is not the strong arm of the Lord but its vast nuclear armaments which point in all directions⁶⁰⁷. To true Jewish minds this is the Israel of Jeroboam not King David, and Saul is well equipped, well armed and will not be dislodged as easily. Oh, how the mighty are fallen, when the Messiah returns as Babylon falls and to see this watch Israel not Persia.

All of these Israelis, who are dissatisfied with the administration and shape and philosophy of Israel cannot be traitors only dreamers with a passion. The Christian west could not support such philosophies and aims, yet the western elite nevertheless do – the only motive is oil any spiritual motivation is entirely misplaced but determined and not a mistake.

The war against Islam is puzzling and goes back to the start of Zionism, it is particularly puzzling especially when Muslims in America are more numerous than Jews⁶⁰⁸. The disturbing scenes we see in Israel today existed then, yet despite this there existed in Palestine a Freemason lodge where Arab and Jew existed peacefully together⁶⁰⁹ and today the Masonic lodge in Jerusalem admits both Arabs and Jews ...there is in harmony three lodges one for Christians, one for Muslims and one for Jews, and all regard each other as brothers. Three being a significant number what is their secret and why cannot this ability for peace find accord outside the lodge.

Well ask the Shiners of America, to become a Shiner you must have been at least a 32° degree Freemason. Its membership allows you a Fez, great parties and a fully illumined invitation to the mysteries of Sufism (Islamic mysticism e.g. whirling dervishes) its blend of the Cabala, with Pythagoras and Islam was made famous by Elephas Levi, member of the Golden Dawn⁶¹⁰ (with W. B. Yeats and Alistair Crowley)

The impact which Sufism and the Cabala and therefore Islam has had upon the enlightenment is starting to be recognised. Sufism shaped Islam in the 7th Century in that it completely captured it, providing the five pillars of Islam with its mystical foundations. A second impact was upon the Knights Templar, never before had a group of warrior monks had the opportunity to not only receive the knowledge of a Christian and Hellenic philosophy, including Jewish mysticism and the mystery religions of Isis, but also the combined knowledge of the eastern mysteries. The adoption of the “Tree of Life”⁶¹¹. Cabala rites ensured that Islamic Sufism (which can be traced back to Chaldean, (Babylon) and Egyptian rites) has become instrumental with Jewish and Islamic Freemasons.

The Shiners adopt the Knights Templar degrees in the York or Scottish rite, whilst the Cabala in Judaism has declined in importance, it is still the frame in which to reach enlightenment. When beginning this “way” the travellers have abandoned all claims to be Jews or Muslims in the traditional sense. Following the science of Astrology, Astronomy and Pythagorean mysteries both Osama Bin Laden and Al Quaida could converse across the Universe, and especially to brother Bush and the Republican party or Democrats without terrorising many Jewish leaders in America and without anyone dialling 9/11.

However, birds of a feather do flock together regardless of extra-curricular responsibilities and wars rarely attack the leaders or generals only the cannon fodder has that privilege.

To the traditionalists amongst Christianity, this vision of Israel is not one they would recognise. Generally Judeo-Christianity follows in a straight line, a history of the covenants given to the Hebrai and Israel and to Christians Jewish or Gentile in the Gospel and New Testament. There are 8 covenants in the Judeo-Christian tradition and are easy to follow.

1. **The Edenic Covenant** ..featured in this are the two trees ..the first is the tree of life and the second is the tree of the knowledge of good and evil As this covenant was broken when Adam and Eve, tasted the fruit of the tree of the knowledge of good and evil a further covenant or covenants were introduced .as follows

2. **The covenant with Adam and Eve** given in year one !.(after leaving the garden of Eden)

3 **The Covenant with Noah** or the Noahic covenant (Eight survived in the Ark)

4. **The Covenant with Abraham**, the father of many nations Israel and Isaac and Jacob, or Arab and Hebrew

5. **The Covenant with Moses** ..the Mosaic covenant made with Moses 430 years after the Abraham covenant .Following the exodus from Egypt the covenant was given at Mount Sinai

6. **The Palestinian Covenant**, (r.e. the promised land or Palatine). given to the second generation Israelites, following their failure to follow the Abrahamic and Noahic covenants. It is attached to the Abrahamic and Noahic covenants, and one in which God explains that the land is HIS, and as a landlord he will only permit his tenants the tribes of Israel, to remain if they follow a moral code or law.

The most specific term in the contract was the keeping of the Seventh Sabbath year and the Jubilee Sabbath rest for the land including the 50 years observance of cancellation of debts.

7. **The Davidic covenant**, made with King David, father of Solomon. The promise of kingship is contained within this covenant, and is promised to the seed of David from where the future messiah will come.

8. **The New and Everlasting Covenant**, the Crucifixion and Resurrection of Jesus Christ, ensuring salvation to the Gentiles and the Jews.

Although the last is not a Judaic covenant (although at least 10,000 Messianic Jews disagree.) without these covenants there is no Judeo – Christian tradition.

Between the six and seventh there lies the gap between Judaism and Christianity to Judaism there is not a No. 8. To Christians No. 7 is a reality but it is fulfilled and extended under No. 8. Therefore the granting of the land of Palestine to the Jews, is extended to all those who are bound and who are obedient to the covenants

In the Judeo-Christian tradition, Palestinian Christians would therefore have a right to this inheritance.! And the land of Palastine. The boundaries however, of the New Jerusalem and Israel are over the whole earth, where the Gospel should be preached. The greatest of all Jews was King David. He spent many years being pursued by Saul who had his anointing and kingly inheritance removed by Yahweh through his prophet Samuel. Samuel instead anointed David but Saul refused to accept this.

David in turn could not take up arms against Saul, and so he and his growing followers travelled around the land of Israel, but within its borders. One day he decided to cross over the border to outrun Saul, but the prophet Nathan refused to travel over proclaiming that David and the Israelites would be outside of Gods protection and law, if they crossed over from Israel. David replied to the prophet as to whether Yahweh would be different on the other side .. of course he would not. Christians regard David as a type of Jesus Christ, who would open up salvation originally given to the Jews, but now also to the Gentiles, in effect crossing the border..

Judaism regards this as blasphemy and Jesus claim to be the Son of God as a blasphemous statement worthy of death. Islam regards Jesus as a great prophet but not a divinity, whilst Judaism is regarded as having its prophets from Abraham down to Zechariah. Islam is not concerned if Judaism regards Jesus Christ, as a prophet or not. All of these prophets to Islam are inferior to the prophet Mohammed, who lived six centuries after Christ, who is a prophet or a divinity above all.

Israel however, was never to enter a covenant with nations who worshipped other gods. Christianity for that matter receives all covenants filtered through the 8th, which it regards as the fulfilment of all the other 7 (N.B. Judaism still monotheistic).

In 1931, Zionism in the depression, once again sought funds from a Rothschild, Baron Edmund. The seeker in this case was Chaim Weizman, Israel's first president. He was successful and apart from beginning new soil cultures, almond trees, mulberry bushes, jasmine, mint and tobacco he also started the Palestine Electric Company, the Portland Cement Company and others⁶¹² Placing Utilities and building gains into Jewish hands

At the same time David Ben Gurion negotiated with the British over Palestine and regarded the Bible as his mandate citing the United Kingdom period of David and Solomon as a double incentive to quickly restore Palestine to the Jews.

However, Christians and Jewish Financiers from Wall Street were financing the rebuilding of Germany and Adolf Hitler's Nationalist Socialist Party⁶¹³. Many have stated of course this is the Anti-Semite view, but researchers who are not considered Anti-Semitic, have also highlighted the links between Wall Street and Hitler⁶¹⁴.

Anthony Sutton has published a monumental three volume work detailing how western technology and finance from Wall Street and/or London has supported and built Russia into its soviet status for 1917 to 1965⁶¹⁵. Mr

Sutton points out that both Karl Marx and Adolf Hitler have their philosophies based on Hegel and Kant, without a paradox! Albeit, individualism and brotherhood are a paradox!

Hitler's view of the world shares the same view as the current administration of George Bush and George Bush himself, since the same philosophies in the early 1800's were behind the skull and crossbones, and the Order of Oriental Templars (O.T.O.) which included Alistair Crowley, member of the Golden Dawn. Also included in the Golden Dawn was W. B. Yeats, who later on struggled with his blending of cabalistic mysticism and his Fascist yearnings⁶¹⁶.

Hitler however took the pagan rites of Wagner and the Thule society grown out of the O.T.O. and made up his national socialism to encourage Germanic pride in their Odinic Fatherland (Hitler became the all – fatheror Furher the God of War)

He was raised a Roman Catholic and in 1905 was infatuated with Stefanie Isak, a Jewish girl from Linok, whom he loved dearly ... his Anti-Semitism hardly appearing at this stage⁶¹⁷, concerned as he was with the dreamworld of Knights and Wagnerian maidens.

His sojourn in England gave him access to Alistair Crowley “the beast” and helped him familiarise himself with Liverpool, which he later would take great pride in bombing (knowing the best areas of manufacture first hand). He fought in WW1 and after Germany's defeat the bankers in Germany and Wall street and England (supposedly mainly Jewish) were blamed for the failure.

On his rise to power was greatly assisted by his influential friends, and on his way up through the 1930s he slowly eliminated any powerful groups which would threaten him later.

The Freemasons were high on his list, especially lodges which were Jewish in membership. However, the old guard Prussian lodges which refused to admit Jews were allowed to continue, and Hitler ensured their survival.

This indicates not as commonly taught a total all out hatred of Jews, but rather a hatred of Jewish Financiers which, to the National Socialists then and today are a threat to their (Anglo-Saxon) control of the world finance. “The idea took root in Anti-Semitic circles that to do away with the Jews would, at one fell swoop, do away with Capitalism and Socialism”⁶¹⁸. So cites former Israeli soldier Haim Bresheath.

Six million Jews were killed and many millions of gypsies, not including the many millions of civilians in Britain, Europe, Asia, Australia, Japan and China over this issue of world finance. Handicapped people, were also especially likely to be killed, being as they were in the mind of the Nazi's impure, imperfect and as a result of mixed marriages. ! Whether the distinction between all Jews and Jewish control of money is true or not, arguments rage over this moot point (to all the dead concerned) and can make the difference between whether you anti – Semitic or not.

This was Hitlers final solution, a solution which concluded,that if the chosen people did not exist then the worlds money would not flow always to them. (as Gode has promised to give).Of course a debate on just who the chosen people are (between Christians and Jews) is ongoing.

Israel was born after all this preparation of 110 years in one day fulfilling the prophecy in Isaiah. Yet what kind of Israel is it, in the 1950s, says ex-Israeli soldier Haim Bresheath⁶¹⁹. Zionist agents planted a bomb in a synagogue in Baghdad. For hundreds of years Jews and Arabs had existed in peaceful co-existence, but the bomb created a “artificial” wave of Anti-Semitism creating a mass exodus of Jews from Iraq.

This true story reflects the view that if Ant-Semitism does not exist, then Zionism provokes it..... of course the opposing view is that Zionism came into existence because of the persecutions and hardships of Jews, which Anti-Semitism brings.....which came first.?

It is difficult for anybody looking into this, to know who is telling the truth and who is not, and it will not be made easy, it is a permanent war.It si a relevant point because in the Judeo- Christian tradition (which many say should just be termed Christian tradition) outward expansion by love in spreading the Gospel is essentially ...hate is the anti-thesis...this is a way of disquingusihing “the sheep from the goats”

Revelations from newly released documents reveal how UK agents allowed the “Bombing of Britain” to occur to “convince the Germans that their agents were still working effectively” so a double bluff, very clever, except to the dead in the blitz The agents were working for MI5⁶²⁰., Presumably King Edwards sympathies for the Nazi invasion was a rouse to convince Hitler that Anglo-Saxon, Oriental Order of Templars, Wagner loving tribe of Dan types were also still working effectively, with their cousins in the Fatherland !.

Only where eagles dare, can the apparent double bluff be taken to mesmerising extremes, when a “German” airplane, staffed by those in German uniforms be the real English. As they fly into England, place this together with the OSS becoming infiltrated with “Ex Nazis” and you can actually start to wonder who won the second world war.

It is this type of scenario and the obvious disregard by Jews and Christians throughout the last hundred years surrounding the “money question” and the creation of Israel, which leads to doubt and scepticism over any of the issues being debated.

A further point concerns the way in which Jewish nationalists have studied the promise of God to restore Israel, which was waiting for two thousand years and then forced his hand⁶²¹.

Obeying Yahweh or walking in his ways was not de-facto, but was also dependent on one's attitude and state of mind and heart at the time you enact or receive from him. What does it gain if you get the whole world and lose your soul. Well many Jewish people today are complaining Israel has lost its soul. Shalom is not just a blessing, but a deep feeling from inside. The promise may have come to pass, but it is hollow without the presence of God. Forcing his hand was achieved as follows according to one prominent journalist Douglas Reid, who is considered anti-semitic.

“The ten northern tribes, with their separate development, had drifted so far from their kindred in the south that the chronicle of their fall takes the form of a brief bold statement of fact unrelieved by any expression of grief. No epic poem, no dirge, no sympathy marked the hour of their downfall”. “This quote from Dr Kastein),

Douglas Reed continues,

“The student of the controversy of Zion⁶²², has to plod far before he begins to unveil its mysteries, but very soon discovers that in all things it speaks two tongues, one for “the heathen” and one for the initiates. The Levites of that ancient time did not, and today's Zionists do not believe that the Israelites “vanished without leaving a trace” (as Dr Karstein says). They were pronounced “dead”⁶²³.

Here Reed likens the disappearance of the lost ten tribes to excommunication. “The true meaning of the assertion that ‘Israel disappeared’, is to be found in the later Talmud which says “the ten tribes have no share in the world to come”. Thus the children of Israel are banned from heaven by the ruling sect of Judah because they refused to exclude themselves from Mankind on earth”.

The great sin of Jeroboam and the apostasy of mixing with the heathen causing Israel no longer to be a pure race. As masters Judah had banished Israel not just on earth but in heaven also. Douglas continues,

“The Chief Rabbi of the British Empire in 1918, the very Reverend J. H. Hertz, in answer to an inquiry on this point said explicitly
“The people known at present as Jews are descendants of the tribes of Judah and Benjamin with a certain number of descendants of the tribe of Levi”...
“this statement makes perfectly clear that ‘Israel’ had no part in what has become Judaism (no authority), Judaist or other; could support this claim made to blood-descent from Judah, for the Jews of today, but this is of little account”.

“Therefore, the use of the name ‘Israel’ by the Zionist state which was created in Palestine in this century is in the nature of a forgery. Some strong reason must have dictated the use of the name of a people who were not Jews and would have none of the creed which has become Judaism. One tenable theory suggests itself. The Zionist state was set up with the connivance of the great nations of the west, which is also the area of Christendom. The calculation may have been that these people would be comforted in their consciences if they could be led to believe that they were fulfilling Biblical prophecy and Gods promise to ‘Israel’ at whatever cost in the destruction of innocent people”⁶²⁴ the last thought is that Israel should be termed Judah or Judea.

By creating an artificial Isreal, it becomes de-facto the fulfillment of prophecy that Isreal would one day be restored. Now it is fulfilled it becomes like the curse of Midas, who in receiving his wish could never hold anyone he loved again.

Similar to this suspicion is the view concerning Gods covenant or promise that all the wealth of the world will pass to his chosen people. As surely as promises come to pass this must surely occur also. If Israels prophetic fulfillment of becoming a nation in one day has happened, then it is inevitable that the worlds wealth will pass to the Chosen people, (whether they wish to receive it or not, they will anyway,) The extreme hatred of anti-semitic views concerning the greed of the Jews fails to take into account that being a recipient of Gods promise makes them innocent of gaining it, despite themselves. What they do with it after this is up to them. If they do not honour the promisor then it will crumble.

This aside, the fulfilment of Gods promise must in any case come to pass,..... if as a Christian, your faith follows the source from which it has sprung. Therefore which comes first, the promise to fulfil or the realisation it has happened, because the biblical vision to have a United Kingdom and central rule in the Holy Land was not always Gods vision as Jeroboam and others attempted. In other words, has the promise now fulfilled, been hijacked?

Mr Reeds views have been deposited in the Anti-Semite area of literature, yet he contends the present Israel is Saul, whilst the proposed promise, (now hijacked) is David.

As the inevitable is going to occur, then choosing the next best thing (or worse) corrupt the image and make it something else. a kind of great deception.

When Jerusalem becomes the centre of world politics⁶²⁵, and the centre of world government, it seems that Messianic Jews, will be prominent in that rule, facsism will not.⁶²⁶

Today, having travelled through so much violence, Israelis are afraid to rid themselves of Ariel Sharon, (or a strong military presence) for fear without a strong military presence, the Arab backlash would turn against them and so they live in a war zone trapped. If they criticise the situation, no matter if you have served in the Israeli military, the Knesset, or a faithful Rabbi, they will be branded as self hating Jews whilst outsiders as Anti-Semitic.

An interesting debate on the Jewish question⁶²⁷ is discussed just after the second world war by A. K. Chesterton an Anti-Semite.,(at a time when Ireland moved from its status as Irish Free State from 1922 to a full Republic in 1942) although he maintains it is the money question not the Jewish question which is his goal. Also a party to the discussion was Joseph Leftwich, who was Jewish, not a Zionist, but a pro-Zionist in sympathy, both were English and soldiers in the British army.

To give a flavour of their discussions a more contemporary scene was set by Woody Allen in one of his films set in Manhattan.

On his way to a bookshop he was approached by a blond Nordic looking gentlemen, who said “D’you have the time” on checking his watch Woody suddenly wondered if the Arian had actually said “Jew have the time” and in a panic suddenly saw the man as a member of the master race who was in

fact intimidating him in a subtle but in your face sinister manner, insinuating it was his time !.

After running away he was comforted by a girlfriend who said he was imagining things .Later whilst again browsing books he noticed the same Nordic man staring at him across the shop ...he could not convince anyone of the intimidation he was feeling, and left the shop in a typical flustered Woody like manner.

Chesterton and Leftwich debated just what is “English” and what is “Jewish” a topic they both discussed,

English to Jewish Joseph Leftwich was an amalgamation of Celt, Saxon, Dane and Norman, does Mr Leftwich see his duty to England first or to Israel. asks Chesterton

Mr Leftwich ask similar questions of Mr Chesterton, asking is he first and foremost Celt, Saxon, Dane or even German.? The point being that England is not run or ruled by the “English” or for the “English”, therefore it is run by Jewish interests (which Mr Leftwich doubts) would they not in any case see their duty to England first and so the question revolves into circular argument

Chesterton who starts his chapters (written as letters to Leftwich and vice - versa) with “My dear Leftwich”, whilst Leftwich returns with “My Dear Chesterton” all very polite

Chesterton first points out that both (his namesake) G. K. Chesterton and Hillaire Belloc were not Anti-Semites but ...Anti Zionists!

Leftwich in a separate point states “I seem to remember quite a lot being said (in Chesterton’s first letter to him) about the commercial morality of businessmen in general, whether they are English, American, German, French, Calvinist, Presbyterian or what you will, and if some Jewish businessmen are no better it is because they are businessmen, not because they are Jews”,

he continues later “Research has refuted the belief that Jews are pure Semites and Germans pure Nordics”,

and he adds that the “Jewish world conspiracy” would require centuries of efforts to maintain “and would have driven us mad”.

Chesterton rebuffs with “Henceforward the dollar will control the world and if Jews do not control the dollar it will be the most incredible lapse in their history” and “there are said to be only about fifteen million Jews on Earth, how comes it that they so infallibly rise to the top?” Chesterton goes on to note the similarities between Zionist fanaticism and Nazi fanaticism pointing out both were inspired in part by Frederick Nictzhe who was Jewish.

“I might have been at a Hitler Youth gathering” Chesterton quotes a friend who attended a Zionist Youth rally in London “I could distinguish no difference in spirit whatever, between these young Jews and the Nazi youth of the old days”.

Chesterton then points to Golders Green and the North End Road and Golders Green Park area. Many nationalists live in this area he adds, but as soon as one Jewish family moves in, it attracts another, until the “atmosphere of the neighbourhood undergoes a change”. They then attend your local institutions and stand for local councils and are elected. English people in their own land and locality begin to feel like strangers. The implication is that they joined Masonic lodges and if any one protests, cries of “anti-Semitism” are heard nullifying any protest at all. In time they become landlords, start businesses and in time run the country.

Chesterton expresses this as utterly frustrating, he takes Leftwich’s quote to identify how he sees the Anti-Semitic problem

(Leftwich) “In a whipping matter (i.e. the Anti-Semite) the whipper must stop”

Chesterton adds that if a schoolboy has been whipped by a schoolmaster and was in effect constantly chastised by him, then that is a case when the whipping should of course stop, “but should it be found that the same pupil (the Semite or Jewish person) had met with the same treatment from all masters in the world-wide diversity of schools and – if the metaphor may be stretched so far – in almost every age, then it seems to me, pretty plain that the investigation should begin with an inquiry into the psychology, not of the masters, but of the boy himself”.

Of course these were pre-corporal punishment schooldays and now we “chastise” instead of using a whip (which they, as I have myself suffered) and so in ever decreasing circles, the charioteers from Ben Hur spin around the argument.

Which came first Anti – Semitism, or overt Jewish nationalism, against the world...and so the debate would return to the beginning possibly even the book of Genesis itself, and into the minutia of eating apples it seems.!, it becomes as inscrutable as the Cabala itself.

Even during the “Secret middle-east peace talk” Sinn Fein and Unionists and Jewish and Palestinian delegates (as described in the previous chapter), also found similarities between Ireland and Israel. Which came first “anti Celticness” or “anti- Unionism”

Roman Catholic, Anglican, Presbyterian and Methodist (and others) ministers have it seems used the cloth to disguise their paramilitary activities, to maim, torture and murder in the province.⁶²⁸, Is God on their side during this activity, who is aggressor and who is victim. ?

Leftwich points out that the Jewish Chronicle drew parallels between the Jewish terrorists in Palestine and the terrorists in Ireland. “Methods of insurrection and exasperation on the one hand and a policy of repression on the other”.

Leftwich then points out the irony in both positions brilliantly.

He points to the “perception” of the international Cabal of Jewish conspirators, controlling the worlds finances and slowly enslaving those who are not of their kind, is a description which could be equally applied to Christianity and the western Christian civilisation with equal plausibility.

As for Ulster, if Zionists are playing the Anti-Semite card, whilst secretly instigating violence against those who they are accusing in Israel, does this mean that the “English” are doing the same in Ulster.

The conflicts of the centuries of Empires declining and Empires rising, rubbing awkwardly against each other in different locations.

Leftwich points to the matter of Irelands Partition from an article in the Dublin Irish Press. The article blamed the British for having got herself into the awkward position between Jews and Arabs in Palestine.

“the world will as clearly understand how we too, were tricked by mutually exclusive promises and the partition of our country carried out by even a worse deception than that practiced on the Jews and the Arabs”.

The article then promises that like the Arabs and the Jews their Diaspora will make partitions as awkward for the British. this shows that the British interests in the middle east were not always the same as the Zionists.

Partition is a tool which is placed once a economic threat is established, and in order to mask the real intentions, sectarian hatred, albeit dormant is whipped up by the Imperialists, or the occupiers (those who have most to lose financially), so that the wider world can see the “border” more clearly.

In India in 1869, a 2300 mile long artificial hedge of “closely clipped thorny bushes”⁶²⁹ was planted down the middle of India, from the Indus to the Mahanadi in Madras, guarded by 12,000 men, it would have stretched from London to Constantinople.....its purpose to

“secure the levy on a duty of Saltthere grew up a monstrous system, to which I would be impossible to find a parallel in any civilised country”⁶³⁰,

(a custom line in effect) This was said by Sir John Strachey, who was a member of the Indian civil service, armies then as today do not operate through democratic channels. Who today is even aware of it.

Rival “barbarians” of Indian tribes and peoples revolted against this of course, and presumably were classed as terrorists...the terror being to the east India company's lost profits.

Indians did not plant the hedge or ask for it, it was imposed, artificially created. This is the real cause of partitioned angst in partitioned countries.

We have already seen the Red line agreement map in the previous chapter, which drawn in 1928 some 20 years before Israel was created in “one day”, that the British motives in Palestine were not to fulfil biblical prophecy but to secure a flow of Oil.

Similar interests i.e. financial have led to a long convoluted rewriting of history on why Ulster is British. The British as Celts of course are not implied as Celts but as Anglo Saxons, something that no Archaeologist or historian would claim the British to be

Leftwich is showing Chesterton that invasion and partition of Ireland is a direct and motivating cause of the violence, not the other way around.

In this context Chesterton a British army officer (an anti – Semite or anti – Zionist depending) is brought to book for criticising Zionists in Israel, but ignoring plantations his own have created in Ireland...yet Chesterton would still blame the “world wide Jewish conspiracy” for bringing both situations about. (Bolshevism being the fuel in the 1916 Easter rising in Eire, according to the British white paper from the home office as cited earlier, the Bolshevicks being primarily Jewish led, according to the Whitehall document)

Confused, well remember also that the Republicans in the May 2002 elections were considered as Palestinians, behind the Palestinian flag ? and the Unionists as Isreal, under the Isreali flag?, could the Zionists have supported Irish Palestinians ??...they did in 1916 ??, have “Irish” tribes changed DNA ? both in any case are from a lost tribe of Isreal !

Cohen (meaning Priest in Hebrew) in E.I.R.E. is pronounced Cohan. (remember the “Irish” are considered the tribe of Dan, and the British Emphraim or vice versa ?)

Indeed the thousand of dead citizens testify in Palestine and Ireland, how the dialectic of Hegelism works to their detriment. Forced into hatred, they generate conflict, which generates the need for arms and taxes to sustain the incumbent army. The wealth of which flows back to London stained with blood of Ulstermen of whatever religious belief. The news on BBC 1⁶³¹ recently carried a quote by the Primeminister of Malaysia Mahathir Mohammed (long considered a anti- semite) who complained in a 3rd world conference that “rich nations” are fuelling terror by selling arms to poor countries and waging unnecessary wars, his solution which carries a sad but realistic acceptance of the situation is to increase the tax on arms sales dramatically and give the monies to the countries involved.....this rather than ban the sales in the first place...which came first the war or the sales of arms,without international help would the death rate have decreased ..he seems to think so ..war is profit.!

A time arises for a final solution, did Hitler really believe that in expelling, or gassing all Jewish Socialists and Capitalists, a solution would be found.to the world wide money problem

Like the Wagnerian hero, he played Wagner music to the end when the forces he unleashed went out, revolved and turned upon him.

His bunker was eventually surrounded and then in the final moments he was overwhelmed, the centre of his own Nuclear explosion, when however in true Wagnerian, pagan satisfaction he would be reborn as a Phoenix of his former self. This time however, not as dark, brooding, unhappy, Hitler but as a Knight free,and fulfilled in search of love.

Blending these pagan rites with Judaism was also a final solution for Jewish warriors, as they were dispersed two thousand years before Christ.

Centuries of experience, gleaned from knowledge of other empires and from their own struggles, the Jewish international determined that the Anglo –Saxon empire whether in Berlin or London, would be assimilated .the old Prussian – Nordic order, and the Jewish international prepared for the spiritual battle ahead, one which was at a tremendous cost. As Judaism does not merge with the beliefs of the Nordic sons of Odin easily.The easier passage of the Cabbala to blend with Odinic- Anglo beliefs is easier, thus it becomes the vechile of assimilation.

Every step a war, and every word ammunition against a foe who employed the strength of his enemies against him. Both Chesterton and Leftwich urged each other see the opposing point of view whilst Chesterton sees the

unification of the Judeo- Odinic tradition as a detrimental step in the crusade against “the money question” which Leftwich feels may or may not bring him into conflict against his own.

In the end the Nazi Jewish philosophers (Ashkenazim, although this is certainly not true of every Ashkenazim) and the tribe of Judah rode like Ben Hur and Centurion round the central point of who is in control. A hairs breadth of philosophy separating them with the Cabala providing the bridge to Asgard.

After “ww2” the federal reserve took over from the Bank of England as the controlling world bank and the defeated Nazis, would wait to rise again to impose their New world order,

A central prise in the quest is the control of Israel and the mount of Zion ...or Sion on which the theologians will consult God, or control his covenantal promises by holding the land.!.

Interestingly, a perky Michael Portillo appeared in a interesting and honest Wagner documentary on BBC 2⁶³², he stated he had his own Wagner experience in his political life and was now reborn to begin again. He explained that in order to gain power you have to give up love, but then in wielding power without love, it will ultimately destroy you. Portillo added that if Hitler really understood the Wagner manuscripts he had with him in the bunker, he would have destroyed them

Portillo then travelled to Austria and in a face to face interview with a prominent Rabbi, asked him what he thought of Hitler. The Rabbi replied that Hitler was a “deeply spiritual person” with a high intelligence and understanding of Wagner as indeed the Rabbi did himself, but he wielded this power for evil and not love. A debate about the destructions and morals of persons evil and other ensued ... they both looked tense.

Mr Portillo was then interviewed on a reclining couch by a female “Wagner psychiatrist”. She revealed she had many MPs on the same couch, as Portillo purred. It was not clear however if the Wagner counselling/treatment was to help them out of the “condition” and bring them to their senses, or help them through the necessary and inevitable rise and destruction of ones self in one piece.

Afterwards ... Portillo said he did not now have power, but can now concentrate on love, having experienced Wagner’s ring completely.

And there you have it, I almost expected a finale, with Michael appearing in an all singing – all goose-stepping – all dancing SS uniformed rendition of

Mel Brooks' "Springtime for Hitler and Germany" singing a duet perhaps with the Wagner psychiatrist, on the DANube as the Valkrye fly overhead. I was disappointed but Michael Portillo seemed to enjoy every minute. The baton however seems to have passed to George Bush, who appears behind podiums or at the bottom of airplane steps. He then seems to raise his arm with his hand curved slightly in what looks like a Nazi salute. Perhaps he will burst into "Tomorrow belongs to me" from Cabaret. One cannot help feeling however, that behind all of this Love, there is a bit of the old 'argy bargy' percolating, it seems as if a touch of the old grievous is on the horizon and the 'Clockwork Orange' is about to unwind.. "Psyche lusts to be wet" and the consummation is about to explode with a bit of the Ludwig Van B, taking then to the emerald City via Starship Enterprise, Wagner psychiatrists are to be inundated with appointments.

The "New Right" (Reich) of course is represented by the Anglo American Petro –dollar tribes, who oppose the European Latin tribes They sometimes unite however if a third steps into the contest.

The third faction is a blend of European part Norman supposedly part Jewish tribe known in mediaeval histories as the Merovingian kings and one of their bloodline Descendant of these kings is the House of Spencer, included in it of course was Princess Diana.(Stewart) Spencer.

It has to be remembered that the Merovingian Royal Houses emerged in the dark ages as the most powerful force in Europe and the world

The Spencer's are able to trace their ancestry back through the Stuart Monarchs and therefore to King James 1 of England (James V1 of Scotland) and to Robert the Bruce, and therefore the Celtic High Kings of "Ireland and Scotland"

The quest in the bloodline of the Windsor's and the house of Spencer was the early links to a Judaic bloodline. From all accounts most historians believe the Windsor's bloodline (Sax – Coburg's) to be extremely tenuous, especially in comparison to the House of Spencer.⁶³³

The Windsor's who are able to lay claim to the throne as King James 1st daughter Elizabeth married Frederick of Bohemia, and their daughter married Sophia married German Elector August of Hanover. Thier son William of Orange, was installed on the throne in effect by the Bank of Amsterdam, to form the Bank of England, who in turn drew their success from the Dutch revolt from Italian banking interests and the Knights of the Golden Fleece. (see chapter 1) Robert the Bruce was half Norman himself so the "usurping" if seen through Celtic histories is deeper than the Spencer's would like.

The Merovingians were from their first grandmaster Godfroi de Bouillion “Kings of Jerusalem” since AD 1099, when they in a crusade captured Jerusalem from the Muslim forces.

The Church of Rome became competitors with them, and a power struggle for control of who should run Christendom’s Holy city (Rome) began over the centuries. controlling Rome meant control of Jerusalem the prise ..the Grael.

When the reformation was hijacked by the financial empire of the Dutch, a third major player entered into the race. There are others of course, and the lines are further divided by the non – recognition of the Judaic bloodline belonging to Christians, when a Jewish bloodline for those who are practising Judaism and are circumcised is more appealing.

What is remarkable in all of this is the fact that His Right Honourable Prince Michael James Alexander Stewart king of Scotland and England (or Albion), was refused a passport recently when his old one expired, he can now longer travel, and on applying for a new one he was visited by “some of her Majesty’s office or other” and he was asked if he intended to acquire his new HRH passport in order to lay claim to the throne of Great Britain. the home office wrote to him and officially addressed his as H.R.H,both recognising his title, but keeping him away from his rightful throne⁶³⁴. ?

Even more remarkable is the genealogical record proving this link originally found in France was procured by M16 and the security forces at great effort to keep it from public view.

Prince Micheal credit cards display HRH, and he is recognised by 33 of Europe’s most senior royal houses. His title as titular head of the throne of Scotland, and legal pretender to the throne of Britain, is officially recognised in international law, and ratified by the International parliament, and further endorsed by the United Nations.....but not by the Bank of England or Parliament.

There is even a Austrailian Republican who it is thought is the actual King of England, due to the Tudors being illegitimate by birth.

This faction is represented by the Priory of Sion.

The Hanoverian Sax Coburg’s Petro dollar Anglos are represented by the current house of Windsor MI6 and the Knights of Malta, and the Vatican city which is a small Empire in itself.

To Jewish interests all are disinherited in their claim to be Kings or Queens of Jerusalem by faith and birth. Alongside the competitive factions within the

tribe are the two distinctions described earlier. All pointing towards Israel, which awaits its king. All of this is surrounded by people who could not care less and see money as the main motivator, especially Oil.

All of this of course rides on being able to prove a bloodline directly to the House of King David and Solomon, and this is the bloodline from where the Messiah would rise and reign over Jerusalem, as the centre or capital of a new world empire. If all of these bloodlines prove to be a mistake then of course none of their claims are valid. We shall examine these claims briefly in the next chapter

As for Princess Diana, her marriage was purely to re-introduce the Stuart bloodline into the House of Windsor and to the throne again, r.e. Prince William (although there are many many more with a greater claim than he). What was unacceptable, was to have a popular and authoritative Spencer capturing the attention, usurping the Windsors. Sarah Ferguson also a Merovingian descendant, also proved to be too “active” for the House of Windsor..or rather the Privy Council, and the Orangemen who sit upon it. For the Muslims to recapture Jerusalem (Dodi) a crusade would also have to be fought, this time near the original HQ of the original Knights Templar in Paris. Helen was not so lucky this time.

If all of this proves to be incredible, it is more incredible that MI6, mounted an operation in France to “procure” the discovered genealogies⁶³⁵, which are supposed to show a line extending back to Jesus Christ's brothers and sisters, they now hold it safely locked away.

Therefore who is the rightful King of Jerusalem.....only time will tell. Since the destruction of the temple in AD70 most genealogical records, were lost. This hardly matters since the Messiah's return will be obvious.

The modern state of Israel is the biggest threat to the peoples of Judah, it has always been so since 1947 in its present form, and it is those Jews who Joseph Leftwich describes as true to their heritage and tradition in Moses and the covenants, which constitute true Judaism

The “money problem” rather than being an issue which is used to insult Jews, is one in which they can help to solve. The war zone in which Israel exists was described by Haim Bresheath as a Frankenstein⁶³⁶. The monster trying to kill its creator. The tribes of Judah are indeed made to suffer, but it is the inner Orthodox Jews which like King David, seek after God, after his heart, not his law alone which are made to suffer the most. When the first civilisation realised that by borrowing to another, 100 pieces of silver,

expecting 110 in return and knowing there was only 100 pieces in circulation, it was a fait accompli, and the beginnings of slavery to Jews and Gentiles alike and is an issue separate from their characteristics or personalities.

The current ground zero area in New York is currently under development. A monument truly worthy of this site is a homeland which recognises the different languages of the victims who fell with the towers. The relatives of the victim feel dissatisfied with the current proposed model.

Instead we could have a true monument, a personal Architecture in which it is the thought that counts. ..this is or would be the tallest building on the horizon.

Instead we have a glass tower which is a monument to international finance not to the consumers who are its victims

The Gangs of New York are still waiting for an explanation of why 9/11 could have happened, and the media fury of who, why and wherefore has proven to be hollow and a sham. The growing unease and lack of feeling that America is a democracy and the land of the free, is instead turning into the land of keep silent, big brother is watching. Go along with the flow and blame who we are told to blame, and the real reasons become lost in the latest editorial or newsflash. Facism always works in this way.

Finally It becomes a mystery nobody can discern and the ground zero scar becomes the missing piece in the mystery of the big apple.
